Notes

- 1) Figures for Number of Authorized Vouchers and Voucher Funding are HUD data. Voucher Funding, 2009 is the sum of 2009 formula renewal funding, including any reserve (NRA) offset amount, and allocations received from the \$100 million in set aside funds. It does not include amounts from the \$30 million in "extraordinary administrative fees" distributed by HUD in August.
- 2) Figures for Number of Families Using Vouchers and Monthly Housing Assistance Payments are data reported by agencies to HUD's Voucher Management System.
- 3) Figures for Funding Reserve Balance (i.e., "net restricted assets" or NRA) are HUD estimates. These amounts include unspent housing assistance funds from prior years, but exclude amounts used as an offset to renewal funding eligibility in 2009. They do not include administrative fee balances.
- 4) Estimated Funding Shortfall and Number of Vouchers Unfunded are CBPP estimates. Estimates assume that: voucher usage remains at the May level for the remainder of 2009; per-voucher cost inflation from June to December continues at the same rate as from October 2008 to May 2009; and agencies spend all remaining reserve (NRA) balances, excluding an amount equal to 1 percent of estimated 2009 expenditures. Because Voucher Funding figures used do not include \$30 million in extraordinary administrative fees allocated by HUD in August, actual shortfalls may be lower at some agencies (for this reason, the figures in this table also differ somewhat from those published by CBPP on September 14). In addition, because shortfall estimates are calculated from HUD data (primarily VMS data), this list does not include agencies experiencing shortfalls due to HUD data discrepancies that affected funding awards in 2009.
