

EIC Participation for Tax Year 2005, by State



These *preliminary* figures show the number of EIC claims in each state approved and paid by the IRS in 2006 (for tax year 2005) and the total dollar amount of these claims in each state. These numbers will increase somewhat as more tax year 2005 returns are processed. For rough comparison purposes, the reverse side shows claims for tax year 2004.
