

The Supplemental Nutrition Assistance Program (SNAP) is the nation's most important anti-hunger program.

## Who Does SNAP Reach?


In Fiscal Year 2014, it reached:

- **87,000** Alaska residents, or **12%** of the state population (**1 in 8 people**)
- **46,536,000** participants in the United States, or **15%** of the total population (**1 in 7 people**)

### In Alaska many households still struggle to put food on the table:

- **11.8%** of households were "food insecure," or struggled to afford a nutritionally adequate diet, in 2011-2013.
- **6.3%** of the population was unemployed in December 2014.
- In 2013, average income in Alaska was **0.1% below** the 2007 level.
- **9.3%** of the population lived below the poverty line in 2013.
- **11.8%** of children lived below the poverty line in 2013.
- **5.2%** of elderly lived below the poverty line in 2013.

**SNAP reaches needy populations: 73%** of eligible individuals participated in SNAP in Alaska in 2012. In Alaska in FY 2013, **86%** of households receiving SNAP had income below the poverty line (about \$23,850 for a family of four in 2014), and **46%** of households were in deep poverty, with income below 50% of the poverty line.

## What Benefits Do SNAP Recipients Receive?

SNAP targets benefits according to need. Very poor households receive more SNAP benefits than households closer to the poverty line since they need more help affording an adequate diet.

Households receive SNAP benefits on electronic benefit transfer (EBT) cards, which can be used only to purchase food at one of the 252,900 authorized retail locations around the country, including 500 in Alaska.



## How Does SNAP Benefit the Economy?

Moody's Analytics estimates that in a weak economy, \$1 in SNAP benefits generates \$1.70 in economic activity.

SNAP benefits pumped about \$174 million into Alaska's economy in 2014.

**Note:** Due to a higher cost of living, Alaska has different eligibility, deduction, and benefit levels than the continental U.S. Alaskan SNAP participation declines annually following the increase in income residents experience from the receipt of dividends from the Alaska Permanent Fund.
