

INCOME INEQUALITY HAS INCREASED IN NEW JERSEY SINCE THE 1970s

Inequality has increased in New Jersey over the past two decades. This can be observed by ranking all New Jersey families according to their income level, dividing them into five groups (or fifths) of equal size, and calculating the average income of each fifth of families. This analysis shows by the late 1990s:

- The richest 20 percent of families had average incomes 9.6 times as large as the poorest 20 percent of families.
- The richest 20 percent of families had average incomes 2.8 times as large as the middle 20 percent of families.

The Long-Term Trend

Since the late 1970s, income inequality has increased in New Jersey. The economic growth of the 1980s and 1990s was not shared evenly among the poor, the rich, and the middle class. Instead, the top fifth of families fared substantially better than other income groups.

In the late 1970s, the richest 20 percent of families had average incomes 7.0 times as large as the poorest 20 percent of families. By the late 1990s, that ratio had grown to 9.6. This increase in inequality was the 12th greatest in the nation. The gap between the rich and the middle class also increased. This increase was the ninth greatest in the nation.

In the late 1970s, the richest five percent of families had average incomes 10.0 times as large as the poorest 20 percent of families. By the late 1990s, that ratio had grown to 15.2.

Between the late 1970s and the late 1990s:

- The average income of the poorest fifth of families increased by \$3,070, from \$15,880 to \$18,950.
- The average income of the middle fifth of families increased by \$15,000, from \$49,600 to \$64,600.
- The average income of the richest fifth of families increased by \$71,470, from \$111,190 to \$182,670.
- The average income of the richest five percent of families increased by \$129,290, from \$159,540 to \$288,830.

The Recent Trend

Over the past decade, income inequality has increased in New Jersey.

In the late 1980s, the richest 20 percent of families had average incomes 8.1 times as large as the poorest 20 percent of families. By the late 1990s, that ratio had increased to 9.6. This increase in inequality was the 13th greatest in the nation. The gap between the rich and the middle class also increased. This increase was the ninth greatest in the nation.

In the late 1980s, the richest five percent of families had average incomes 12.4 times as large as the poorest 20 percent of families. By the late 1990s, that ratio had grown to 15.2.

Between the late 1980s and the late 1990s:

- The average income of the poorest fifth of families decreased by \$30, from \$18,980 to \$18,950.¹
- The average income of the middle fifth of families increased by \$1,320, from \$63,290 to \$64,600.
- The average income of the richest fifth of families increased by \$28,750, from \$153,910 to \$182,670.
- The average income of the richest five percent of families increased by \$53,160, from \$235,670 to \$288,830.

¹ The direction of this change is not statistically significant at the 95 percent level of confidence.

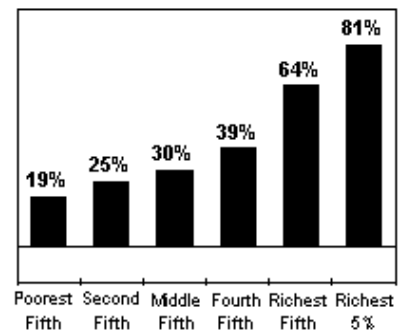

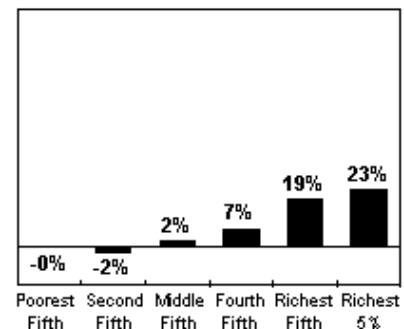
