



## How Would the Medicaid Expansion Affect Wisconsin?



### Who is eligible for Medicaid today in Wisconsin?

Medicaid eligibility today varies greatly from state to state. In many states, parents cannot get coverage unless their incomes are very low and many adults without dependent children cannot get coverage at all. In Wisconsin, the income eligibility thresholds for Medicaid for the different categories of eligibility are as follows:

### How many currently *uninsured* adults would be eligible for Medicaid in Wisconsin?

In Wisconsin, there are currently 235,000 *uninsured* adults who would be eligible for Medicaid if the state expanded its Medicaid program. Of these, 181,000 would be newly eligible for Medicaid if the state expanded, while 53,000 are eligible for the program under current rules but are not enrolled.<sup>1</sup>

### How many more people would enroll in Medicaid if Wisconsin expanded?

If Wisconsin expands Medicaid, an additional 211,000 adults who will be newly eligible for the program will enroll. These comprise mostly uninsured adults, but also include some adults who currently have other health care coverage.

Even if Wisconsin does not expand, enrollment is expected to increase by 62,000 as parents and children who are already eligible for Medicaid enroll in health coverage because other aspects of the Affordable Care Act (ACA) including the requirement for people to have coverage or pay a penalty, outreach to enroll people into exchange subsidies, and improved coordination and simplified eligibility procedures.<sup>2</sup>

### How much would it cost Wisconsin to cover these individuals through Medicaid?

Wisconsin will spend \$973 million more on Medicaid to cover additional enrollment of currently eligible children and parents through 2022 with or without the expansion. The expansion though would reduce state spending by \$248 million. Altogether, this additional spending is just 1.8 percent more than what Wisconsin would have spent on Medicaid in the absence of the ACA.<sup>3</sup>
