The Food Stamp Program has made severe hunger rare in America. In the late 1960s, medical research exposed the fact that American children suffered and died from diseases related to severe malnutrition that usually are thought of as occurring only in third-world countries. In 1979, after the Food Stamp Program became available nation-wide, physicians discovered that this severe malnutrition had become rare, a result they attributed to the Food Stamp Program. The Food Stamp Program is the largest anti-hunger program in New Mexico.

### FOOD STAMPS HELP VULNERABLE NEW MEXICO RESIDENTS AND THE ECONOMY

- 233,918 New Mexicans use food stamps to buy food every month.<sup>1</sup> That amounts to 12 percent of the people in New Mexico or one in eight New Mexicans.
- New Mexico food stamp households receive, on average, \$0.99 per person per meal in food stamp benefits. This modest amount is crucial to financially pressed families.
- The Food Stamp Program pumped \$248,844,870 into the New Mexico economy last year, benefiting farmers, grocers, and small businesses throughout the state.<sup>2</sup>
- About 83 percent of New Mexico food stamp benefits go to households with children, many of them in working families.<sup>3</sup> Most of the rest go to households containing elderly people or people with disabilities.

### FOOD STAMPS HELP PEOPLE THROUGH HARD TIMES

- During the recent rough economy, Food Stamp Program participation in New Mexico increased. In 2000, an average of 169,354 New Mexicans received food stamps each month. That number rose steadily to 233,918 in 2007, an increase of 38 percent.<sup>4</sup>
- Using the flexibility provided in the Food Stamp Act, the U.S. Department of Agriculture (USDA) is able to quickly issue disaster food stamps to people that survive hurricanes, tornadoes, or other natural disasters.

## UNMET NEED REMAINS

- Still, about 35.5 million Americans have difficulty affording food. An estimated 124,000 households in New Mexico live with hunger or the threat of hunger, according to USDA.<sup>5</sup> That includes low-income working families and senior citizens living on fixed incomes.
- One in six children (17 percent) lives in families that have difficulty affording adequate food, according to USDA.<sup>6</sup> A household with a child under six is about twice as likely to suffer from food insecurity as a household with no children.
- Nationally, only 65 percent of those eligible for food stamps receive them. In New Mexico, the participation rate is estimated to be 69 percent.<sup>7</sup>
- Increasing the share of eligible households that participate in the Food Stamp Program by just five percentage points, New Mexico would provide food stamps to an additional 17,000 low-income New Mexicans, bring \$8.3 million into New Mexico's local economy, and result in \$15.3 million in new economic activity.<sup>8</sup>
